Notes to Financial Statements: Treasurer's Report

Trumpeter Club Invested \$5,000.00 in a term deposit with Van City. Was renewed in October 2015 Maturity Date 23 Oct, 2018. interest rate 2016: 1.1%, 2017: 2.5%, 2018: 2.2%

Interest transferred to Community Service Account annually.

Lower interest rates than on our last term deposit, but to be expected

Budget Notes

Significant drops in Membership and Door revenue both from 2015 (down by \$1200) Interest income was down from 2015, as expected due to lower interest rates Concession on budget, but sales were down in 2016

Expenses overall were up over from 2015, a result of both more aggressive prize support
